

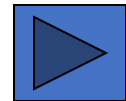

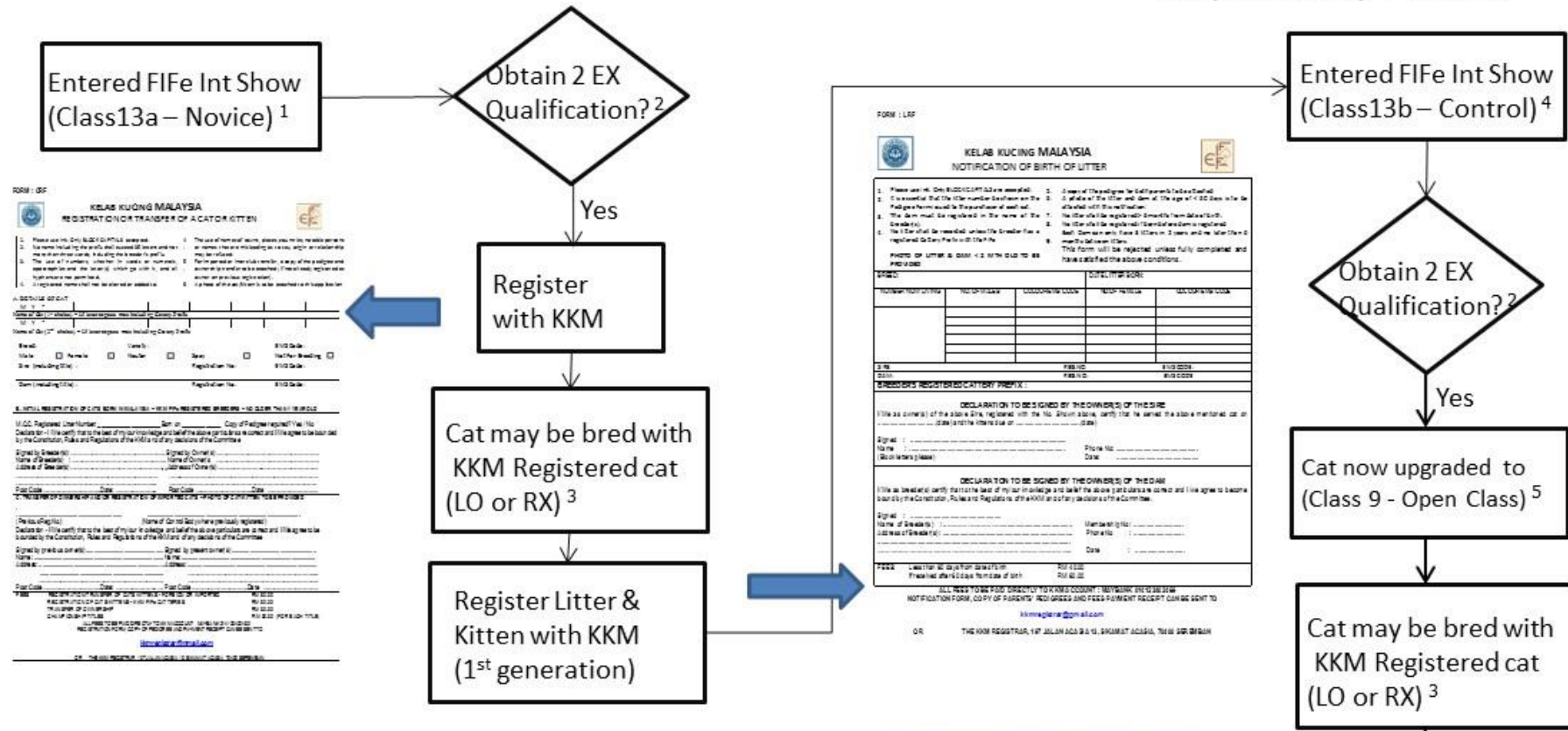

1 Novice Class - adult cats of the age of over 10 months

2 The qualification obtained must be from 2 different Int Judges; can be from a single Show or 2 different Shows.

3 Novice cats registered with KKM can only be bred to another KKM registered cat (LO or RX) of the same target breed.

4 Control Class – Above 4 months

5 Can now compete for CAC and BIS

6 Kitten registered is issued an RX pedigree and can compete in Class 12 (Kitten 4-7 mths) onwards and for BIS

All judging reports must be submitted to the Registrar for stages 1-5

Neutered Novices can compete in Class 10 – for CAP after stage 2

Only cat's with FIFe Registrations are eligible for the Show Certificates and Titles.
Cats with Non FIFe Titles are initially entered in Classes 9/10 until registration transfer is done with FIFe.
Non FIFe Titles can be shown in the pedigree of offsprings.

¹ KKM recognizes winners of Best In Category 1/2/3/4 or Best Msian Bred cat as eligible for DSM

² KKM recognizes the winners of Best M'sian Bred Kitten as eligible for JW

DVM/DSM are awarded after a minimum period of two years between the first and the 10th BIV/BIS

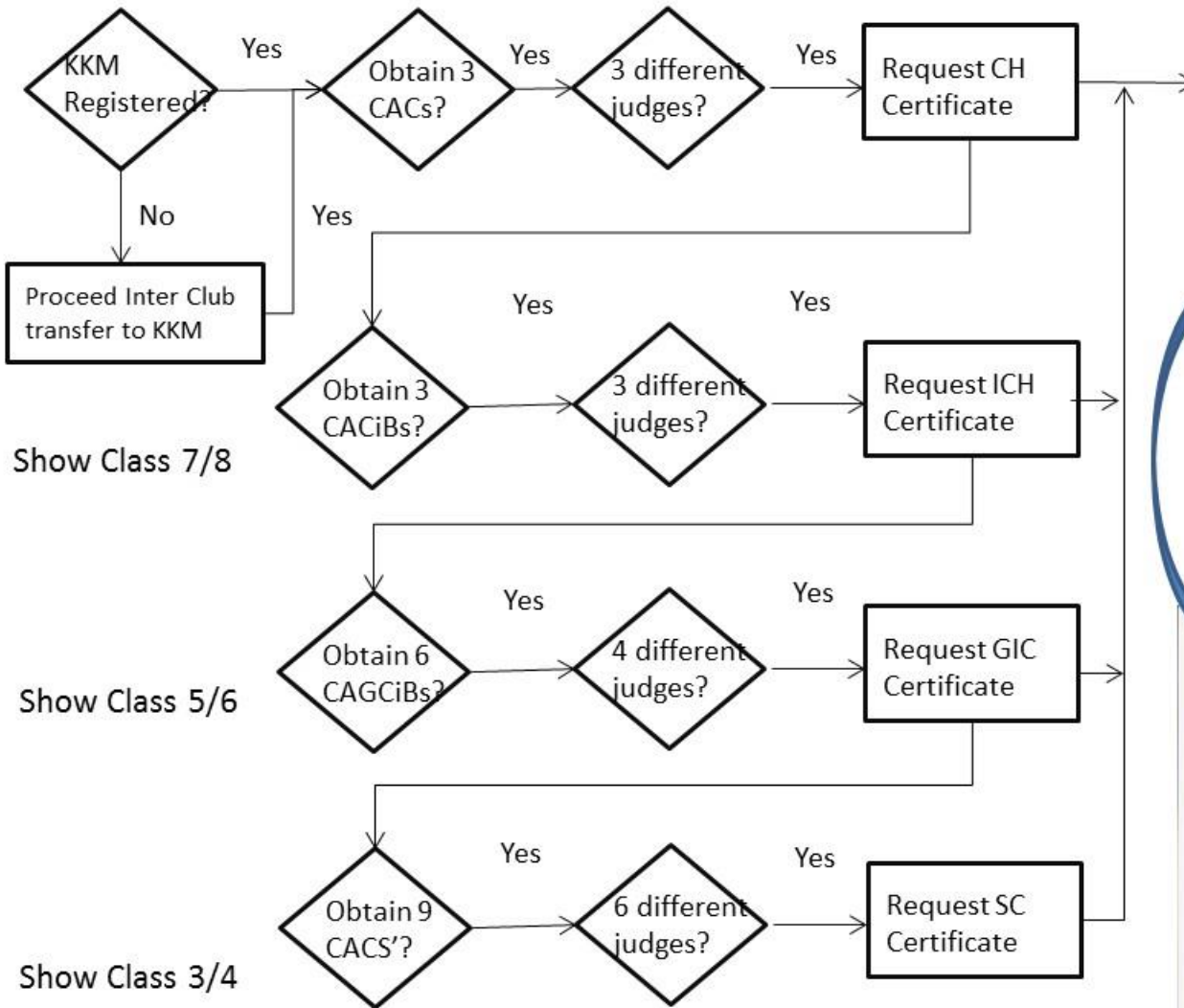
